## **Dog Licensing**

Chapter 174 of the Wisconsin Statue requires owners of dogs more than 5 months of age on January 1 shall annually pay the dog license tax and obtain a license. All Green County dog licenses for dogs residing in Albany Township must be purchased via U.S. Mail. Cost is \$5.00 per spayed/neutered dog and \$10.00 per unaltered dog. Multiple dog licenses are available for \$35.00 for 12 or fewer dogs and an additional \$3.00 for each dog in excess of 12. A late fee of \$5.00 per dog *could* be assessed if a license is not obtained by April 1. Remit payment along with a copy of your <u>Vet Certification</u> for each dog showing date of rabies vaccination to:

Make checks payable to the Town of Albany. Allow 10 days for processing. Make sure a return address is included.
