Public Input:

Dennis N. presented a possible public nuisance and asked about any zoning or ordinances (or other types of assistance that may be available). He was asked if there was any covenants for the col-de-sac and stated that it had expired. It was suggested that maybe Dennis could share with the board the verbiage that had been used in the past – further discussion that Dennis circle back with Jeffery Briggs – to discuss a possible environmental issue as well as this being a possible concern of the school district (busses) and have them consider a complaint.
